- 7. Add trees or something (?) at canal bridge entrance on 3rd Ave. Henry Discussed the benefits and potential problems of amenities, do not want to attract crime, decided to research land owner and contact the city for input and assistance.
- 8. 2014 BW Grant approved. Charley Total is \$9,874.00, for dead-bolt door locks, paint address numbers and alley fences, lighting in alleys and canal bank, newsletters and office supplies.
- 9. Traffic update, new study. Chris Discussed resident reports of excessive speeding on Pierson, 1st Ave and 3rd Ave, Chris was introduced to Kerry Wilcoxon and traffic study has been ordered and approved by Kerry.
- 10. 1st Ave & Elm/Highland, Davis parking. Davis is in escrow, plans to use this site for parking for Hula's center, will dustproof, board decided to request landscaping improvements adjacent to the neighborhood.
- 11. Central & Highland, apartments construction starting. Developer advised they plan to break ground in 2 weeks, discussed potential problems with trucks in the neighborhood, construction start times, dust proofing, etc., discussed the responsibility of residents to document violations and report, and decided to inform residents of same if/when violations occur, Chris and Ray to monitor.

  - 13. Historic Preservation, application to the Federal Register. No update.
